

Labels - Women's Consignment Store – Contract for Consignment

We are very happy to have you consign with our store! Thank you.

1) Labels Women's Consignment Store will determine the items to be accepted for re-sale in our store. We accept only CLEAN, CUTE and CURRENT items with no stains, rips, musty or smoke smell. Washed and folded in a bag works best for us. They must be in good selling condition and within the last few years of purchase. If any items are found to have defects (holes, missing buttons, stains, zipper) after we take them, we reserve the right to donate them to charity with no notice given.

INITIAL HERE _____ I realize that when I say "YES" to Donate on the Check In sheet, ALL my items could be donated to Charity. (Otherwise please say "NO" and wait for items to be returned to you on the day you bring in for consignment. If you fail to wait for returned items, they will be donated to charity.)

2) Labels will set the prices but we appreciate input from you on special or expensive items. Before consigning your items, be sure that if any item is expensive and/or you require a minimum amount from it that write it on the sign in sheet. We keep our prices very reasonable, approximately 50-80% off retail prices. We reserve the right to markdown or put items on sale at any time. **You will receive 40% of the selling price** less a \$0.50 - \$2.99 per item fee.

3) **The consignment period is up to 60 days; 30 days full price and up to 30 days half price.** You can pick up your items anytime but we recommend you do so in the first 30 days. After the consignment period any unsold items become the property of Labels and may be donated to charity. We support any donate to these local non-profits. **We Care, Snip, Snip, Hooray and Ragfinery.**

4) **When there is a positive balance on your account it is yours to take as Cash or Store Credit:** Payments to you for under \$100 are given in cash, over \$100 a check is written (if a manager is in the store, if not, it will be mailed to you.) It is your responsibility to inquire and collect any money owing from your account, we do not notify you when your items have sold and you have money on your account.

5) After one year from clothes drop off date you will no longer have the option to take the balance as cash and it will automatically convert to an electronic gift certificate that we will email to you at the email address you list below. If you do not provide an email address, we will mail a paper gift certificate to the mailing address you list below. It will be your responsibility to notify us of any change to your email address or mailing address. The gift certificate will never expire.
